

# FAMILY/DOMESTIC VIOLENCE



Domestic violence is defined as the abusive pattern of behaviour demonstrated by one person towards another in an effort to gain and maintain coercive control in relationships. Taking many different forms, including physical, verbal, emotional, sexual, financial, spiritual, and psychological abuse, domestic violence is a serious issue that negatively impacts couples, spouses, children, family, and friends. Often hidden, shame, silence, and guilt are its signatures. Domestic violence occurs across society, regardless of age, gender, race, sexuality, wealth, religion, socioeconomic status, and geography.

Do you find yourself in a situation where you feel your relationship has eroded significantly with elements of domestic violence in your life or in the life of a loved one or friend? Perhaps you have experienced an instance(s) of domestic violence, or have participated in the abuse, but feel afraid or unsure of what to do about it. Whatever your situation may be, seeking help or guidance may be a first important step in reversing the negative impact domestic violence has on your life and on the lives of those around you.
